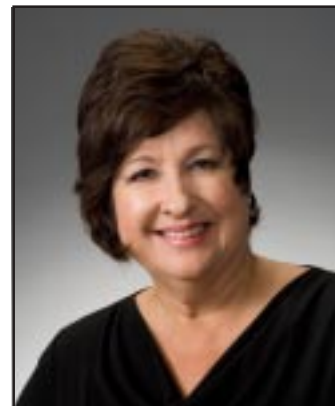

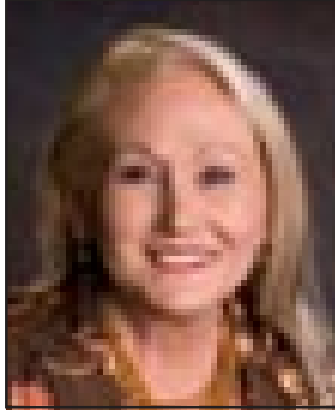

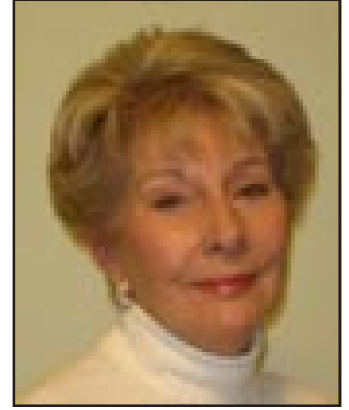

### Economic Development Update

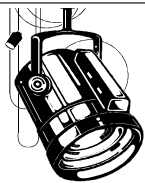
